## Item 2025-4-5 Regional Sport Development Workforce Program

Justin Forbes, Director of Operations/Planning Director spoke of the briefing the Board had received on a potential funding opportunity to express interest in a Regional Sport Development Workforce Program. It had been requested by a Board member to put the item on the Agenda again. Mayor Robichaud suggested if the position is created, perhaps it can be used to assist Member Communities develop/enhance their own programs that could ultimately be aligned within the Region over the next decade. Justin advised members that he had been in touch with the funding contact and they will hold off on release of funding until the Board completes it's review. The Commission would continue with the Operational Review for 2025 and provided that the review rationalizes the need for the position, then it would move forward. There would be no costs to the Communities. Justin confirmed Mayor Russell's question that there is no actual money coming from the Communities. Mayor Munn voiced his concern that when more staff is hired, there are more cuts in equalization grants. Mayor O'Donnell asked how long it will be for the Terms of Reference to be completed. Justin Forbes will bring a draft copy to the April meeting, but it will be a few months before much direction again. Mayor O'Donnell suggested not to commit to funding opportunity until documents are completed, showing it is advantageous to do. Mayor O'Donnell suggested a motion be put on the table to vote on.

Mayor Lordon, who was not present at the meeting, sent an email to be read, stating he agrees with Justin Forbes, Director of Operations/Planning Director on the following motion:
